



FAMOUS AND SHAMELESS STALLION SERVICE CONTRACT

2023 Breeding Season

The parties to this contract are By The Book Barrel Horses ("BTB"), the owners of Famous and Shameless ("Rodman"), AQHA #5753671, 2016 Black stallion, 15.1 hh, Five Panel N/N, IMM N/N, and LWO n/n and EVA Negative and _____ hereinafter referred to as Mare Owner. Mare Owner has engaged BTB in one service to Famous and Shameless for the mare _____, AQHA (or APHA, ApHC) # _____, hereinafter referred to as the Mare, for the 2023 breeding season (the breeding season shall begin January 1, 2022, and end June 30, 2022 at a fee of \$1350.00 (USD).

1. A non-refundable booking fee of \$500 is payable with this contract and the entire balance plus all unpaid expenses (including collection & shipping charges--\$400 Fedex for cooled/frozen, \$650 counter to counter,) will be payable prior to shipment of semen.
2. The Mare Owner shall agree that the mare offered for breeding shall be in sound breeding condition and free from infection or disease. Any mare certified by the attending veterinarian not to be, in their opinion, in sound breeding condition, shall not be bred. It is the Mare Owner's responsibility to verify health and breeding soundness of the mare. It is further agreed that should the above-named mare die prior to foaling, the Mare Owner may substitute another mare, to be used in the following season only, if it is agreed to by both the Mare Owner and BTB. Pregnancy exam must be completed within 30 days of insemination.
3. Mare Owner agrees to assume responsibility for all facets of breeding the mare and agrees to use all semen provided under this agreement solely to breed the Mare named above. Any attempt to use any portion of any semen shipped to Mare Owner to breed any other mare shall automatically terminate all obligations of this agreement and result in forfeiture of all breeding fees, shipping fees, booking fees, and the right to a breeder's certificate. Any resulting foal from such unauthorized use will immediately make due to BTB liquidated damages of \$2000.
4. Live Foal Guarantee: Live foal means that the foal shall stand and nurse. It is understood that if the mare proves barren, aborts her foal, or if the foal is stillborn, a rebreed will be guaranteed the following year only, provided proper notification is given. Proper notification shall be defined as follows: Written certification by a licensed veterinarian within seven days that the mare has slipped or produced a non-viable foal. Mare Owner certifies that such abortion or death did not result from any act or omission of the Mare Owner (this shall include abuse or neglect). No rebreed fee shall be due should a rebreed become necessary. However, the Mare Owner shall be responsible for any shipping or collection fees for

rebreds. Rebreds are only available the year immediately following the initial contract breeding season.

5. A Breeder's Certificate will only be issued to the Mare Owner upon request and notification of birth of the foal. Mare Owner shall contact BTB no later than August 15th of the foaling year.
6. Multiple Foals: The payments provided in paragraph 1 are for one foal for this breeding season from this Mare. Should more than one embryo result from a breeding Mare Owner shall pay an additional Breeding Fee within 60 days of confirmed foal for each additional embryo or foal. No breeding certificate for any foal will be issued without additional payment.
7. Unless otherwise expressly agreed to in this contract, semen provided for the 2022 breeding season shall be cooled semen. The mare owner shall be responsible prior to shipment of semen that the persons or entity performing the insemination shall be trained and prepared to handle cooled semen using industry standard insemination techniques. If cooled is not available, frozen is available. All frozen insemination attempts shall be via deep horn insemination techniques. Any attempt to inseminate the Mare by a person that is not qualified for standard cooled techniques or deep horn frozen insemination shall automatically void the Live Foal Guarantee. Any attempt to inseminate the mare by techniques other than industry standards shall automatically void the right to rebreed the mare.

Choice of Law and Venue

Any disputes arising out of this contract shall be settled under the laws of the State of Texas. Any suits arising under this contract must be brought in the County Court at Law of Cooke County, Texas. All parties to this contract consent to personal jurisdiction of the County Court of Law of Cooke County, Texas regardless of where they may be found. Should any suit be brought in any court other than the County Court at Law of Cooke County, Texas BTB shall be entitled to reasonable attorney's fees and expenses to dismiss such suit or have it properly transferred to the County Court at Law of Cooke County, Texas. Notice of any such suit shall be made to the agent of BTB, Karen Campbell at 1762 CR 121, Gainesville, Texas 76240.
